## **MariMed Hemp Signs Exclusive Agreement with Major Beverage Distributor to Market its CBD Brands in Rhode Island and Connecticut**

NORWOOD, Mass., Sept. 25, 2019 (GLOBE NEWSWIRE) -- [MariMed Inc.](#) (OTCQX: MRMD), a premier cannabis and hemp multi-state operator focused on health and wellness, announced that the HempEngine™ group of its MariMed Hemp subsidiary has signed an exclusive agreement with one of the largest beverage distributors located in the Northeast U.S., serving more than 8,500 on- and off-premise locations.

Under the terms of the agreement, the HempEngine platform will be placed in locations in Rhode Island and Connecticut that include retailers, liquor stores and supermarkets. These locations will receive the HempEngine turnkey CBD marketing platform, a complete “store-within-a-store” package, pre-stocked with a range of CBD products focused on a location owner’s particular criteria. In addition to curated brands, HempEngine includes the tech-enabled re-marketing platform, [Sprout™](#). HempEngine supports retailer sales and marketing decisions to maximize returns and sales efficiency. The rollout is expected to begin in October.

“This major distribution agreement enables MariMed Hemp to further penetrate the fast-growing hemp CBD space,” commented MariMed CEO, Bob Fireman. “Its revolutionary platform creates powerful new distribution opportunities for our hemp-derived CBD brands.”

The HempEngine platform collects real-time data and pre-screens the data for quality and content. It includes an electronic tablet that provides shoppers interactive, educational information about CBD product attributes, benefits and usage at the point-of-sale. HempEngine provides customized marketing solutions that educate, facilitate and drive mainstream CBD distribution.

“Our HempEngine team worked closely with the distributor to develop a custom CBD product line that will be deployed through their expansive distribution network,” noted David Schachter of HempEngine. “Given the distributor’s large regional customer base and dedicated team of sales professionals, we see this initial roll out of HempEngine developing into a substantial new revenue stream for MariMed Hemp.”

The commercial launch of HempEngine follows MariMed’s significant [investment](#) in [GenCanna Global](#), the Kentucky-based leader in production of GMP quality CBD derived from hemp. GenCanna recently [announced](#) its engagement of Goldman Sachs & Co. as its

financial advisor to assist in evaluating a potential initial public offering and other strategic financial alternatives. MariMed formed MariMed Hemp to build and distribute a portfolio of innovative CBD brands, and pursue business opportunities in the emerging hemp and CBD industry.

MariMed Inc., a multi-state cannabis operator, is dedicated to improving the health and wellness of people through the use of cannabinoids and cannabis products. The company acquired a significant stake in Kentucky-based GenCanna Global, a national and international leading cultivator, producer, and distributor of hemp and GMP quality CBD oils and isolates. With this strategic relationship, MariMed Hemp has developed and is marketing a portfolio of CBD brands and products to multiple retailers and direct to consumers both domestically and internationally. MariMed Hemp recently launched its Hemp Engine™ store-within-a-store distribution platform for retailers. It is also actively pursuing other hemp industry business opportunities with genetics, farming, biomass, and new and innovative technologies.
